## TEAM PLACEMENT INFORMATION

Iconic Cheer Elite is a 9-month program. We begin practicing in September and continue through June. June is pre-season evaluation month. The majority of the teams will practice 2 days a week with additional practices added if needed before competitions. Fundraising will also help to offset the cost of season tuition.

All travel obligations are due to be paid in full by end of January 2017. Speak to our office manager about payment plans if needed.

Levels: Iconic Cheer Elite will continue into our third year with the ability to have teams from level 1 to level 6. The "level" refers to the type of tumbling, stunts, and pyramids that can be performed in the routine. As the numbers for the levels increase so does the level of difficulty of the skills allowed to be performed in the routine.

Placement: Iconic Cheer Elite will match the athletes by all-around skill level which includes; stunt, tumbling, jumps, dance and age. The coaching staff in coordination with the USASF skills/age grid solely determines the team that the athlete is placed on. Athlete's team placement CAN change based on summer progress, availability, or any other issue deemed to be a concern or conflict by the coaching staff. Coaches reserve the right to move athletes up or down in level if found necessary. Trust the coaching staff, we want all our teams to be successful.

Evaluation Process: The evaluation process is meant to be a fun low-stress atmosphere. Since we are working with athletes who have passion for the sport of cheerleading, we want to foster an environment that is fun and where skills and talent shine through. The athletes will demonstrate the tumbling skills they have already developed and possess. Stunting skills will be instructed and then performed with spots and coaches carefully. Once the evaluation is complete the coaches will determine the team placement and athletes will be notified via email within 5-7days.

### PROGRAM COSTS/TUITION

Competitive cheer, while not as costly as some youth activities, can still be expensive. Before considering this or any program, please consider the financial commitment involved. Tuition is paid monthly on the 1<sup>st</sup> of every month. The first two month's fees include competition costs and uniform. This is due to the need to pay for uniform and competitions first to avoid late fees and delays in the uniform delivery. The remaining 7 months is broken down into equal payments. The tuition costs include all practices, choreography, music, practice gear, practice bow, competition bow, bag, insurance, and USASF Membership.

Discounts:

There is a 10% sibling discount available for those with siblings that choose to join Iconic together, no matter the team placement.

There is a \$100.00 discount for those who choose to pay tuition in full by October 1<sup>st</sup>, 2018.

Joining the program after tryouts: Because our tuition is all-inclusive there will be a portion of the tuition that needs to be made up to cover all the additional items included in the cost. The first two months will remain the same. The following months will be prorated with the remainder of the tuition costs.

\*\*\*Please note: Dropping from the program early, there are no refunds and tuition is non-transferable and non-refundable. Athletes can receive their uniform once the first two payments are processed.\*\*\*

When will my child get their uniform?

When you sign up to be a member of Iconic Cheer Elite the first two month's payments go towards the cost of the uniform and competition fees. The uniforms will be sized and ordered immediately. We will have all uniforms in hand by the first competition. The owners plan to keep the uniform design for at least two years. The athlete and family will be responsible for any replacement uniform pieces (lost or no longer fitting item), and should notify Iconic Cheer Elite immediately so that the items can be purchased.

When will we know what team we are placed on and the practice schedule?

Teams will be decided after the final evaluation date. Emails will be sent to all athletes with tentative practice days/times as well as the team the athlete has made. If you have not received an email within 24 hours of the announcement of teams, please email [IconicCheerElite@gmail.com](mailto:IconicCheerElite@gmail.com) us immediately.

What if I can't make evaluations?

A private tryout can be held. Email the owners immediately so they can set up a date and time.

What if I can't tumble or have never cheered before? Does this mean I am not going to make a "good" team?

No. All of the teams at Iconic Cheer Elite are "good" teams! Everyone has a place here, as we are a family. Previous cheer experience and tumbling skills are not requirements needed in order to tryout. If you have no experience, the coaching staff will work with you to make you better each day than you were before.

What is a TEAM REP?

A team rep is a parent who is the liaison between the coach and the parents. There is one team rep for the Iconic Cheer Elite Program. The rep is in charge of meeting the team at competitions, handing out wristbands, and assisting with team functions and communication. Team Reps are not involved in gym decisions, coaching, or accounting issues. They are simply there to help organize and relay information.

What is a crossover?

A crossover is an athlete that competes on more than one team in a program. Crossovers are allowed at all events and must follow the USASF guidelines. Participants may compete on up to 2 teams. The owners will make every effort to schedule competitions, warm-ups, and competition times to accommodate crossovers however time between performances is not guaranteed by the event producer. Bring a crossover is a great way for athletes to continue to utilize existing skills and showcase advanced skills. Team members get to experience a variety of roles within teams i.e. basing on one team and flying on another. Being a crossover helps them develop both the skills of a leader and of a team player.

## Parent Communication & Policies

As a parent you will receive information in several ways such as email, GroupMe, text messages, and/or phone calls from the coaches or Team Rep. You can also check [www.IconicCheerElite.com](http://www.IconicCheerElite.com) for updates.

### Fees

- A schedule of payments is listed in this packet. All monthly fees are due on the 1<sup>st</sup> of the month. Auto Pay tuition will be pulled from your account on the 1<sup>st</sup> of every month.
- Please make all checks payable to: Iconic Cheer Elite LLC.
- Returned checks will be subject to a \$35 return check fee. If a second check is returned, the option of checks as payment will be void and no checks will be accepted for any reason for the remainder of the season.
- A late fee of \$20 will be assessed for all payments made after the 5<sup>th</sup>.
- Monthly tuition cannot be pro-rated for any reason and is non-transferable and non-refundable.
- By the 15<sup>th</sup> of each month your account must be up to date. Otherwise all athletes under your account will be moved to an alternate position or asked to sit out during practice.
- A current credit card must be kept on file so that tuition payments can be processed on the 1<sup>st</sup> of the month.

### Fundraising

Your fundraising profits will be directly posted to your account. This involves extra work outside of cheer. However, this could result in paying your whole tuition for the year! Any SURPLUS of credits from fundraisers will be applied towards Iconic Cheer Elite merchandise, classes, or can be gifted to the gym for equipment upgrades.

### Practices

There is a viewing area for all designated parents/siblings. Parents and siblings are asked to stay in that designated area and not to come into the training area. We want your child to get the most out of every practice. In order for this to happen we need their full attention. If there are distractions the whole team is affected and it is a safety issue. Owners and coaches can close practices at anytime for any reason.

If a parent or anyone is observed speaking negatively about a team, coach, parent, cheerleader, or anything Iconic related, he/she will be talked to and/or asked to leave. This can result in the athlete being removed from the team. We will not tolerate any negativity or this type of conduct. If a parent verbally assaults or threatens an athlete, coach, or parent the family will be dismissed from the program.

### Transportation

All transportation/accommodations to local and national competitions are the sole responsibility of each family.

We will make every effort to provide information in a timely manner. However, if a competition is cancelled or rescheduled Iconic Cheer Elite will not be responsible for reimbursement for any reason.

## Parental Support

Your dedication and support is just as important to us as your child. We encourage parents to get to know one another and create a community. This includes sitting together and supporting all Iconic teams. We encourage our parents to wear official Iconic Cheer gear to all events.

Showing respect for the coaching staff, other teams, and hosting organizations is expected, as parents are ambassadors of Iconic Cheer Elite as well as representing your child. Remember we 'Spread Love, It's the Iconic Way!'

## Absences

Attendance is vital to team success. An absence must be documented in writing to your child's coach prior to missing. No practice can be missed two weeks prior to any competition. If you do not comply with this rule, and with the discretion of the coach, your athlete will **BE AT RISK** of missing the competition.

  - Traffic
  - Too much homework
  - Feeling tired
  - Don't have a ride
  - Tardiness
  - Work
  - Family Functions i.e. birthday parties, gender reveals

## Vacations:

Vacations are not permitted during the competition season unless the gym is closed and the athlete has already cleared it with their coaches. Please see your coaches with any vacations at any time.

## Injuries:

If an injury should occur, it is the responsibility of the parent to seek professional help. Each athlete must have his/her own medial insurance. After seeing a physician, please provide Iconic Cheer Elite with an evaluation of the athlete's injury/status. A release from a doctor is required if a serious injury should occur.

## Travel/Competitions:

Transportation to competition is the responsibility of each team member and his/her family. Iconic Cheer Elite will try to arrange travel arrangements i.e. car pools through the team rep.



### Uniforms & Attire:

Please keep all Iconic Cheer Elite practice gear, uniforms, bows, and warm-ups in good condition and in a safe place. Please report any lost or damaged items to your coach immediately. The cost of replacement will be the responsibility of the cheerleader. Please wear assigned gear to practice. It is key for the coaching staff to see the uniformity on the floor when working routine elements. Note that the following items are banned from practices: Jeans, jean shorts, jewelry, long fingernails, hoodies, or anything with a zipper. Iconic Cheer Elite assumes no responsibility for lost valuable items.

### Team Placement:

All athletes are placed on a team at the discretion of the coaches. Age, experience, and skill level all factor into team placement decisions. Please understand that athlete may be repositioned or moved at any time at the discretion of the coaches. Any changes are made to benefit the program as a whole.

### Practices:

Parents are not allowed to come onto the floor for any reason. We have designated viewing area for parents and other family members.

Practice may be closed at any time and for any reason.

### Discipline:

If any of the above rules are compromised, the following actions will occur:

- 1<sup>st</sup> violation: A meeting with the athlete defining the problem.
- 2<sup>nd</sup> violation: A meeting with the athlete and the parent(s).
- 3<sup>rd</sup> violation: The athlete may be removed from the team or entire program.

Do not make assumptions about anything.

Always ask.

Attitude is everything.

If an athlete has a foul attitude, we will place him / her to a non-competitive program, such as a class, until improvements are made. Until then, a replacement will be put in position.

Do not call or text the staff unless it is an emergency. The staff needs to have their personal time away from work. Thank you in advance for respecting this rule.

All cell phones must be silenced once practice starts.

All clothing and belongings must be stored in the cubbies, not thrown on the floor or on the practice floor.

Do not bring items of value to the gym floor. (iPhone, Jewelry, etc..) Iconic is not responsible for lost or stolen items.

The only people allowed in the gym are staff members and athletes that are on the Team Rosters. Parents, friends, relatives and siblings must remain in the viewing room.

Siblings of athletes cannot come inside the gym and watch practice unattended. An adult in the viewing room must supervise them. We cannot baby-sit.

After your child is released from practice, they are no longer under the supervision of Iconic.

Please be prompt when picking your children up from practice, as we cannot have other practices being distracted by unattended children.

**You cannot create or sell your own Iconic clothing. Our name and LOGO are copyrighted.**

**All ideas for apparel must be emailed and approved by Owners.**

Anyone threatening to quit will be asked to leave immediately. No refunds will be given.

Your opinion regarding practice and routine construction does not count. The staff makes all the decisions.

Do not gossip about other teams, parents, other gyms or kids.

Again, if you have any questions, ASK, rather than engage in irresponsible conduct. It is the parent's responsibility to stay informed.

Check your email and website regularly. If you aren't receiving emails, contact the Owners ASAP.

Absences must be cleared and approved by the Head Coach.

Coaches/Directors reserve the right to close practices at any time.

Withholding your child from practice cannot be used as a form of discipline. This is unfair to the rest of the team.

Do not post negative comments, routines or music on social media, You Tube or any website.

Always be an example of good sportsmanship, positive conduct and professionalism at all competitions and practices.

No profanity or rude language.

Punctuality is a MUST. Arrive 10 minutes early to all practices, competitions and functions.

If you are late or dressed incorrectly, you will condition/jump after practice.

Practice schedules can change and any changes will be communicated to parents. We may add practices before a competition when needed.

No food or drinks other than bottled drinks are allowed in the gym.

Remove all piercings before practice. This is non-negotiable as it is a safety issue!

Feel free to talk to your coach about anything. We want to make sure the line of communication is open. Contact Coach for appointment.

**Copyright Notice: You cannot sell or create your own ICE clothing. This includes team names and any other likeness to logo, affiliation and/or program. Parents/Athletes/ Staff wishing to enter a contest, while wearing the ICE Uniform, or representing ICE in any media, must first receive permission from the owner.**

1. Member's and their families must at all times be strong representatives and ambassadors of Iconic Cheer Elite All Stars.
2. No athlete or family members shall drink alcohol or use any form of drugs while in Iconic Cheer Elite attire or at an Iconic Cheer Elite function. If this code is broken it will result in immediate removal from the team and program.
3. Abusive behavior, lying and other negative behavior by a parent or child's is grounds for removal from the program.
4. As a member of Iconic Cheer Elite both athletes and parents are a direct reflection of the program. All social media and other forms of communication (email, message boards, in person) should be positive and promote sportsmanship. Social Media is to include but not limited to; Facebook, Instagram, Snapchat, or Twitter.
5. If you are found writing anything negative or sending rude or inappropriate messages, you will be subject to immediate removal from the team and program.
6. Athletes are required to wear appropriate attire when entering or exiting practice, events, or Iconic functions; sports bras, uniform half tops, and any other revealing attire must be covered by a t-shirt or sweatshirt.
7. When informed of travel schedule, coaches will explain departure locations, dates, and arrival/departure times. It is expected that these dates and times are adhered to and all athletes are at practices prior to competition. We will notify you in advance if we are adjusting travel dates due to flights.
8. All athletes are expected to be at every practice. Excessive unexcused absences will also not be tolerated and can be ground for dismissal from the team and program.

PARTICIPANT AGREEMENT, RELEASE AND ASSUMPTION OF RISK

In consideration of the services of Iconic Cheer Elite LLC, its owners, agents, officers, employees, and all other persons or entities acting in any capacity on their behalf (hereinafter collectively referred to "ICE"), I hereby agree to release, discharge, and hold harmless, on behalf of myself, my children, my parents, my heirs, assigns, personal representative and estate as follows:

1. I understand and acknowledge that the activities that I or my child engage in while on the premises or under auspices of ICE pose known and unknown risks which could result in injury, paralysis, death, emotional distress, or damage to me, my child, to property, or to third parties. The following describes some, but not all, of those risks: Cheerleading and gymnastics, including performances of stunts and use of trampolines, entail certain risks that simply cannot be eliminated without jeopardizing the essential qualities of the activity. Without a certain degree of risk, cheerleading students would not improve their skills and the enjoyment of the sport would be diminished. Cheerleading and gymnastics expose participants to the usual risks of cuts and bruises, and other more serious risks as well. Participants often fall, sprain or break wrists and ankles, and can suffer more serious injuries. Traveling to and from shows, meets, and exhibitions, raises the possibility of any manner of transportation accidents. In any event, if you or your child is injured, medical assistance may be required which you must pay for yourself.
2. I expressly agree and promise to accept and assume all of the risks, known and unknown, connected with ICE- related activities, including but not limited to performance of stunts and use of trampolines. My participation and that of my child is purely voluntary. No one has forced or coerced me or my child to participate. I elect for myself and my children to participate in such activities in spite of the risks.
3. I hereby voluntarily release, forever discharge, and agree to hold harmless and indemnify ICE from any and all liability, claims, demands, actions or rights of action, which are related to, arise out of, or are in any way connected with my child's participation in ICE-related activities.
4. Should ICE be required to incur attorney's fees and costs to enforce this agreement, I agree to indemnify and reimburse them for such fees and costs.
5. I certify that my child has health, accident and liability insurance to cover bodily injury and property damage that may be caused or suffered while participating in this event or activity, or else I agree to bear the cost of such injury or damage to my child. I further certify that I am willing to assume and bear the costs of all risks that may arise or be created, directly or indirectly, through or by any such action.
6. In the event that I file lawsuit against ICE, I agree to do so solely in the state of New York and I further agree that the substantive and procedural laws in that state shall apply in any such action without regard to the conflict of laws rules thereof. I agree that if any portion of this agreement is found void or unenforceable, the remaining portions shall remain in full force and effect.
7. By signing this document, I acknowledge that if anyone is hurt or property is damaged during my participation of any of my children in this activity, I may be found by court of law to have waived my right to maintain a lawsuit against ICE on the basis of any claim from which I have released ICE by signing this Agreement.

I have had sufficient opportunity to read this entire document. I have read it and understand it. I agree to be bound by its terms.
